Special Instruction

Brochure & Giveaways:

Brochure & Giveaways are subject to import duty & tax. Please make sure that freight charges has been stated in both MAWB & HAWB for calculating of import duty & tax.

Control Goods:

Some import goods are subject to import license. License must be available upon arrival at the Kingdom for goods such as motorbikes, used cars, food & beverages, radio equipments, medicines, medical instruments, weapons and all other dangerous goods. Please contact us before the uplift of goods for the show.

Temporary Import:

Exhibition goods are allowed to be temporarily imported. Exhibitors are required to arrange your own bond such as a bank guarantee or ATA Carnet as customs bond for your temporary imports. Trans-Link is able arrange customs bond on behalf of exhibitors upon request.

Sold goods:

Temporary import goods can be sold after the event. Goods must be returned back to the warehouse at the end of the event. It can be only released to buyer upon full payment of import duty & tax to the Thai customs.

Insurance:

As our tariff is computed on the basic of volume and weight and has no correlation with the value of exhibits, it is the responsibility of each exhibitor to arrange Marine/Transport insurance covering transport to exhibition including period exhibits handled by us.

Courier shipment:

If you have any shipment via courier we recommend that you consign the shipment to Trans-Link in Bangkok, so that we can monitor your shipment and contact you immediately if the shipment is detained by Customs. A nominal fee of US\$50.00 per consignment is applicable.
